Dear Parents,

We are excited about our plans for the 2021 Halton Waldorf Summer Camp Program. Camp will run on our **outdoor school grounds** from June 21st through July 23rd. Junior campers (ages 4-6) will enjoy a play-based curriculum interwoven with crafts and outdoor activities. Senior campers (ages 7-11) will celebrate the joys of summer through a variety of stimulating crafts and activities, exploration in nature, music and co-operative games. The leaders of the camp are experienced Waldorf teachers and early childhood educators who provide structure and leadership for a unique and memorable camp experience.

Our camp has always been primarily an outdoor program; however this year outdoor time will encompass most of the children's days. We're excited to offer a fun summer camp experience that will align with any new provincial and regional public health and safety guidelines. Masks are suggested however will not be a requirement of our Junior Campers (ages 4 to 6). Masks are to be worn by our Senior Campers (ages 7 to 11), apart from children with documented exemptions. Mask breaks will be provided at times where the children can maintain a physical distance of at least 2 meters. Children will be kept in cohorts during their camp week (up to 16 children per group).

Daily COVID screening will be a requirement of attending camp. Halton Waldorf School is not able to offer refunds for missed days of camp, this includes when children are unwell or screened out from attending camp.

Please find enclosed dates and costs for the camp as well as a registration form. The registration form must be completed, and **full payment made** to reserve a spot at camp. The early bird discount of 10% applies to registrations and fees received and processed prior to **April 30th**. Applicants are accepted on a first-received basis. Please make cheques payable to the Halton Waldorf School. Payment can be dropped off at the school or mailed to Halton Waldorf School, 2193 Orchard Road, Burlington, Ontario L7R 7J8. We can also accept debit. Please call the school to pay by debit. The debit machine will be brought outside to you to process payment. Families enrolled at HWS also have the option to process payment online via your School-Day account.

Payment is non-refundable for all cancellations made less than two weeks before start date. An administrative fee of \$50 will be charged for refund requests that are received prior to two weeks of the start date. If our school is mandated to shut-down during camp, refunds will apply for days included in the closure.

It must be recognized that there are possible risks for your child that may arise as a result of his or her participation in the camp's activities. Please ensure your children are dressed safely and appropriately and are capable of behaving safely and respecting reasonable authority and all boundaries.

Camp - COVID-19 Screening

The health, safety and well-being of children and staff is a top priority for Halton Waldorf School.

Camp will operate based on the assurance that all persons entering school premises have taken proper precautions to prevent the transmission of COVID-19. As you are aware, the best understanding of the present evidence is that COVID-19 can be transmitted by persons who do not exhibit symptoms. There is no guarantee that COVID-19 will not be contracted by persons entering our premises.

We request that you screen your child prior to arrival at the school each day. In addition to daily active screening, please note that all students will be monitored at school for possible signs or symptoms of illness. As a Parent/Guardian, you must prevent the spread of illness by keeping your child home from school if you or your child experience any of the COVID-19 related symptoms.

If your child experiences any of the symptoms while at the school, a faculty member will contact you or one of your emergency contacts to pick up your child immediately. While your child waits for you or your designate to arrive, s/he will be separated from the other children.

To ensure the safety of faculty and students, all families will be required to complete a one-time attestation regarding COVID-19 daily screening prior to attending our summer camp program.

As a Parent/Guardian responsible for my child, I agree to the following:

1. I have read and understood the Halton Waldorf School Health and Safety Handbook – COVID-19.
2. I understand that prior to my child attending school each day I must complete the Halton Waldorf School Daily Screening Guidelines During COVID-19.
3. I understand that if my child starts to feel ill with COVID-19 symptoms during the school day, they will be immediately brought to the Health Room and their parent/guardian will be called to pick up their child as soon as possible.
4. I understand that if I do not follow the daily screening and send my child to school with COVID-19 symptoms, I will be risking the health and safety of other students and faculty.
5. I understand the risk of illness associated with placing my child in the school.

Student Daily Screening Guidelines – COVID-19

The most important way families can help to limit the spread of COVID-19 is to check their children daily for any COVID-19 symptoms and keep them home from school if they are sick or have had close contact with anyone diagnosed with COVID-19.

Parents and caregivers are asked to perform this screening **daily prior bring their child to Halton Waldorf School**.

Campers should not come to school if they answer **yes** to any of the following questions:

1. Is your child experiencing any of the following symptoms?
 - Fever and/or chills (temperature of 37.8 degrees Celsius or greater)
 - Cough or barking cough (croup)
 - Shortness of breath
 - Decrease or loss of taste or smell
 - Sore throat or difficulty swallowing
 - Runny, stuffy/congested nose (unrelated to seasonal allergies or other known causes)
 - Headache that is unusual and long lasting
 - Nausea, vomiting, and/or diarrhea
 - Extreme tiredness or muscle aches
2. Is anyone your child lives with currently experiencing any new COVID-19 symptoms and/or waiting for test results after experiencing symptoms?
3. In the last 14 days, has your child or anyone they live with travelled outside of Canada?
4. Has a doctor, health care provider, or public health unit told you that your child should currently be isolating (staying at home)?
5. In the last 14 days, has your child been identified as a close contact of someone who currently has COVID-19?
6. *If applicable* - In the last 14 days, has your child received a COVID Alert exposure notification on their cell phone?

If you answered **NO** to all the screening questions your child has passed the screening and can come to camp.

If you answered **YES** to any of the screening questions your child has failed the screening. Please do not bring your child to school. Please contact the main office to report their absence by calling the school at 905-331-4387 or emailing reception@haltonwaldorf.com. Please ensure you indicate in your message that you child has not passed the daily screening.
